DISCLOSURE REGARDING PRIVATE COVENANTS

The undersigned owner(s) of real estate in the _____ subdivision or PUD (the “Subdivision”) in the Village of Bartlett hereby acknowledge that the Village of Bartlett has advised them that there may be private covenants, restrictions and conditions of record (the “private covenants”) which do not allow the undersigned to _____, even though doing so may be allowed under the Village’s ordinances upon issuance of a building permit. The Village does not enforce private covenants. However, under most private covenants a homeowner’s association or any owner or owners in a subdivision have the power to enforce the covenants, including making you remove the improvements and paying for their attorney’s fees if they are successful in any litigation to enforce the private covenants. If you are not sure whether the private covenants allow you to make the proposed improvements, you should review the private covenants before installing them and before entering into a contract to have the improvements installed by a contractor.
